

# Cramlington Town Council Community Chest Guidance Notes 2022/23

Cramlington Town Council will provide grants to voluntary community groups and organisations to benefit, support and improve the lives of Cramlington residents. The maximum grant available is £2500. As there are a limited number of grants available, most successful grants average at around £500. All applications are considered at a meeting of the Community and Youth Committee.

### **Aims**

Cramlington Town Council will support the following objectives:

- Projects or initiatives that will directly benefit the local community
- Projects or initiatives that will directly benefit the local environment
- Projects that develop the skills of community members / groups
- Projects and initiatives that promote networking and collaboration within the local and wider community.

# Who Can apply?

To apply for the Cramlington Community Chest Grant you must meet the following criteria.

- Must be a not for profit voluntary, charitable or community organisation
- Cramlington based or have a significant presence in the town
- Have a written constitution / governing documents
- Have a bank account in the name of the organisation applying for the grant with at least two signatories
- Have unrestricted funds of no more than £10,000

# What cannot be applied for?

The scheme will not fund the following:

- Core running costs, including premises
- Goods and services already purchased
- Personal attire, such as sports kits, uniforms
- Feasibility studies or pre project costs
- Tourism/visitors
- Advertising and marketing

- Social excursions
- Religious or political activity
- Loan repayments
- Annual or repeat funding
- Allotment Sites
- Fundraising and prize-giving

## How are decisions made?

Decisions are made bimonthly by elected members of the Community & Youth Committee.

Applications must be submitted two weeks prior to the Community & Youth Meeting.
